

The Partner Tool is an available option for anyone who is working with a coalition. You may want to use this tool as an activity in your implementation plans. We wanted to share this with you as something you can consider as you layout your work for FY20-21. This would be a good discussion to have in your strategy selection meetings.

Partner Tool

"A social network analysis tool designed to measure and monitor collaboration among people/organizations"



So what is it? The Partner Tool is "A social network analysis tool designed to measure and monitor collaboration among people/organizations"

Designed for use by collaboratives/coalitions:

How members are connected

How resources are leveraged and exchanged

Levels of trust

Link outcomes to the process of collaboration



It was developed specifically for coalitions and collaboratives
It will help you to answer a number of key questions including:
How your coalition members are **connected**How they **leverage and exchange** resources
The levels of **TRUST** among members, and linking **outcomes** to their collaboration

Includes

Online survey for you to administer

An analysis program that analyzes these data

The Partner Tool utilizes an online survey which you share with your coalition and you have access to an analysis program that analyzes this information.

You'll be able to ascertain the quantity and quality of the relationships Any gaps, vulnerabilities or inefficiencies that exist How members can remain accountable and much more.

I've included a link to their website here for you and it includes a lot of good information, including an FAQ

How it Works

- 1. One person designated, "Manager". Will identify survey participants and is responsible for data management
- 2. Members of coalition answer surveys online
- 3. Manager stores data and imports it into the PARTNER tool
- 4. Together, Manager and coalition members discuss results and next steps

The cost for using the tool and also receiving the resulting report is listed here. It would be \$125 per LPHA **or** \$75 if there are 10 or more. An in depth report is \$275 **or** \$225 of there are 10 or more agencies An they offer an abbreviated 2-page highlights only report as well.

Where the tool has the **potential** to be costly, is with Technical Assistance. The hourly rate is \$100. They also offer Demos, Webinars and In-Person Trainings.
